**About the Programme:** The Ministry Housing & Community Development in Partnership with the UN-Habitat is the Adaptation Fund Board to implement the project 'Increasing the resilience of informal urban settlements in Fiji that are highly vulnerable to climate change and disaster risks'. The programme works with vulnerable urban communities to conduct rapid countrywide profiling of climate vulnerable informal settlements, vulnerability assessments for the key 16 identified settlements and to produce action plans and strategies for implementing climate adaptation actions within communities, as well as at town/city level. Underpinning this project is a focus on capacity strengthening in order to enhance the climate resilience of these most vulnerable settlements.
